DIRECT DEBIT GUARANTEE

- If you receive a refund you are not entitled to, you must pay it back when Warwick Independent Schools Foundation asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify Warwick Independent Schools Foundation.
